The last day to file is March 21, 2019, at 5:00 p.m. Candidate filing forms may be obtained from the office of the County Clerk, the respective District Office, or on the County Clerk's Website; www.co.harney.or.us

The petition must be signed by 25 electors, **or** 10% of the electors residing in the electoral district for the office, which ever number is less.
